Whatever changes the Town Board decides on will be forwarded to the Planning Board for their review and recommendations. Nothing further will be done on any proposed changes until the Planning Board has contacted the Town Board.

The Board then began reviewing in a page-by-page format with changes being suggested and acted on as each page was discussed. There were many paragraphs or sections eliminated as it was decided the information was covered in the present zoning ordinance. Dr. Lamb will make the changes, as noted, and a corrected version of the pages will be forwarded to the clerk for the next workshop.

The Board decided to end the review on page 87 and set a second workshop. Messrs. Dooris & Olson made a MOTION to meet on April 30th at 6:00 PM, all ayes.

Old Business-

Zoning Administrator Job Description- Councilman Dooris reported that the draft just needed a few "tweaks" and is now completed. The Board will adopt the final draft later in the meeting.

Little League Pavilion- Councilman Olson reported that he had staked the site out and is putting together a list of materials now. The highway crew will put the posts in so the Boy Scouts can start work on them.

Little League field water line - Councilman Higgins will ask Parker (from Well Company) for suggestions as to how to get this project going. The trench for the line was done last year, but it was late in the year and nothing more was worked on.

Celebration Committee- Councilman Dooris reported on the initial meeting that was held last week. The Committee will meet again in May. The Fire Company, Chamber of Commerce and Boy Scouts are on board as well as other members.

Dry hydrants in Adirondack Lodges- HS Smith asked about the highway going on private property without an access agreement. Counselor Schachner said if Warren County already has an agreement regarding the project it should also name the Town of Horicon on it.

New Business-

Zoning Board Alternates- There was a question regarding term limits for alternates for the Zoning & Planning Boards. The clerk said the Local Law that was adopted to allow the alternates states the term is 5 years. Councilman Dooris said that he would like to appoint alternates who would be willing and able to move up if needed. It is not

helpful if the alternate is not available to be appointed as a regular member when the need arises.

Complaint Regarding Snowmobiles in Cemetery- The Board thought this problem was taken care of when the new fencing was put in surrounding the cemetery. It appears there is an opening in the fence and this will be closed. The people who are riding in the cemetery are know, if this does not stop they will be contacted.

Privilege of Floor-

Mrs. Jane Smith asked why the Zoning Board did not listen to the people opposed to the EZ Marina? Councilman Olson said the project has been thoroughly commented on and everyone has given their opinion 3 or 4 times. Any decisions reached have been done accordingly to the Town's land use ordinance and that is how any project is reviewed. It is not a popularity contest; the Zoning Board is only able to base their decisions on what is in the Ordinance. Mrs. Smith suggested the Town of Horicon purchase the piece of property in question and make it a forever-green space. In answer to Mrs. Smith's statement that laws or regulations have been "circumvented", Counselor Schachner said "it would be illegal for the marina to seek Planning Board approval without ZBA approval, it is all spelled out in our zoning laws". Supervisor Bentley added that it is far from over for this project. If variances are successful the project would need to go to the Planning Board for conditional use. There will be other opportunities to comment. Mrs. Smith said the area in question is the "gateway to Adirondack & Schroon Lake in the Town of Horicon and we do not want to see it commercialized". Councilman Olson thanked Mrs. Smith for discussing her concerns.

Blue Sky- Mr. Thad Smith said the Highway Department did a great job of cleaning up the sand on the roads and kept the roads in good shape all winter. The residents appreciated the work.

At 7: 45 PM the Board moved to Executive Session by MOTION of Messrs. Dooris & Hill, all ayes. Supervisor Bentley announced that Personnel would be discussed. The Board returned to regular meeting at 8:15 PM by MOTION of Messrs. Hill & Higgins, all ayes. Supervisor Bentley announced that Personnel had been discussed in Executive Session, no decisions were reached.

The conditional use lists will then be referred to the Planning Board. Also, the Planning Board will be asked to review any proposed Zoning Ordinance Amendments that come out of this Plan.

The Town Board will meet with the Steering Committee before holding any public informational meetings. When the Board is satisfied the Plan is completed there will be a meeting with the public and the Plan will be submitted to the APA and Warren County. Following these meetings the Town Board will schedule a public hearing.

Dr. Lamb will make the changes from tonight and send the updated pages back as soon as possible.
